Minnesota House of Representatives

The DFL increased their majority in the Minnesota House by a net of two seats. The new make-up of the Minnesota House—87 DFL to 47 Republican—widens the DFL majority but does not give the DFL a veto-proof majority of 90.

The defeated incumbents were either first-term members or they represented districts that have become vulnerable to a shift in voting patterns.

Each of the Representatives-Elect will serve 2-year terms.
