Jeremy also assists clients regarding brownfields, contaminated property remediation, and legal issues arising under CERCLA and MERLA.

A frequent author and speaker on environmental law matters, Jeremy writes a monthly "Environmental Law Update" for the Minnesota State Bar Association's *Bench & Bar* magazine and is past editor of the Federal Bar Association's *Environment, Energy, and Natural Resources* newsletter.
