Successfully defended against a petition for writ of certiorari to the Supreme Court of the United States on the Eighth Circuit decision; *Lundeen v. Canadian Pac. Ry. Co.*, 532 F.3d 682 (8th Cir. 2008), *cert. denied* 129 S. Ct. 2379 (2009).
