GENERAL ORDER 20-09**

This General Order is being issued in response to the developing outbreak of Coronavirus Disease 2019 (COVID-19) and in conjunction with the Court's March 16, 2020, Miscellaneous General Order 20-6 which limited in-Court appearances and continued all jury matters.

The President of the United States has declared a public health emergency in response to the spread of the COVID-19 virus and the Governor of the State of Alaska has declared a public health emergency throughout the state. In order to protect public health through the aim of reducing the size of public gatherings, as well as balancing the fair administration of justice, **IT IS HEREBY ORDERED** that effective **Friday, March 20, 2020**:

ANCHORAGE

All court appearances on Central Violation Bureau (CVB) matters currently scheduled during the month of **April** in Anchorage are continued until **June 2, 2020** at 2:00 p.m. the previously scheduled location.

All court appearances on Central Violation Bureau (CVB) matters currently scheduled during the month of **May** in Anchorage are continued until **June 23, 2020** at 2:00 p.m. at the previously scheduled location.

JUNEAU

All court appearances on Central Violation Bureau (CVB) matters currently scheduled during the month of **May** in Juneau are continued until **June 23, 2020** at 2:00 p.m. at the previously scheduled location.
